Communication in accordance with Article 37-ter, paragraph 3, of the Regulation adopted by Consob with resolution No. 11971 of May 14, 1999, as subsequently amended and supplemented (the “Issuers’ Regulation”) concerning the voluntary and total public tender offers on all shares and warrant of Sourcesense S.p.A. (the “Issuer” or “Sourcesense”) launched by Poste Italiane S.p.A. (the “Bidder”)

Rome, 14 July 2022 – The Bidder communicates that today it has filed with Consob – pursuant to article 102, paragraph 3, of the Legislative Decree No. 58 of February 24, 1998, as subsequently amended and supplemented (the “CFA”) and article 37-ter of Issuers’ Regulation – the offer document (the “**Offer Document**”) concerning the cash voluntary and total public tender offers (the “**Offers**”), in accordance with articles 102 and 106, paragraph 4, of CFA, respectively, on all the shares and all the warrants, issued by Sourcesense.

It should be noted that, Sourcesense’s shares and warrants are both traded on the multilateral trading system called Euronext Growth Milan organized and managed by Borsa Italiana S.p.A..

The Offer Document will be published once approved by Consob, by the end of the review period in accordance with article 102, paragraph 4, of the CFA.

The Offers will be promoted in Italy as Sourcesense's shares and warrant are listed on Euronext Growth Milan organized and managed by Borsa Italiana S.p.A., except for what is indicated below, is subject to the obligations and procedural requirements provided for by Italian law.

The Offers are not and will not be made in United States of America, Canada, Japan, Australia and any other jurisdictions where making the Offer would not be allowed without the approval by competent authorities without other requirements to be complied with by the Offeror (such jurisdictions, including United States of America, Canada, Japan and Australia, jointly, the "**Other Countries**"), neither by using national or international instruments of communication or commerce of the Other Countries (including, for example, postal network, fax, telex, e-mail, telephone and internet), nor through any structure of any of the Other Countries' financial intermediaries or in any other way.
