# **Declaration of accessibility**

# for the persons referred to in Article 3, paragraph 1-bis of Law No. 4 of 9 January 2004

Poste Italiane S.p.A. undertakes to make the website accessible, in accordance with Law no. 4 of 9 January 2004.

This declaration of accessibility applies to the "posteitaliane.it" website (https://www.posteitaliane.it).

## **Compliance status**

Partially compliant.

This website is partially compliant with the requirements of Appendix A of standard UNI CEI EN 301549 due to the cases of non-compliance listed below.

#### Non-accessible content

The contents below are not accessible for the following reason:

#### Disproportionate burden

The Posteitaliane.it website is at the end of life as an experience and infrastructure and will be migrated to a new portal. An the course of this migration, a number of targeted interventions were nevertheless carried out on the pages/functions with the greatest impact, also taking into account reports received from users, which led to tangible improvements in terms of accessibility.

The technical tests were carried out on a representative sample; below are the non-accessible contents for which people with disabilities might have difficulties:

- some functions cannot be reached by browsing from the keyboard (9.2.1.1);
- difficulty in using content for the limitation of user controls available to disable and control scrolling/movement, automatic refresh or flashing present (9.2.2.2);
- browsing with assistive technologies may be limited due to components that cannot be detected or used, or due to the lack of start/end tags (9.4.1.1 9.4.1.2);
- the user's compilation error is not identified on time and no additional, descriptive information is provided (10.3.3.1);
- on some elements, the focus indicator is not visible in the keyboard user interface (9.2.4.7);
- users may find it difficult to browse the contents due to the absence of a keyboard focus order with a sequential order of the contents, to access the main content or a descriptive page title (9.2.4.2 9.2.4.3 10.2.4.3);
- the language used is not correctly identified (9.3.1.1);
- subtitle data is not stored for some audio videos (7.1.3 9.1.2.2).
- for video content in synchronised media, it is not possible to select and play the audio

- description on the preferred audio channel (7.2.1 7.2.3);
- the alternative text that makes graphic elements (e.g. images) accessible to assistive technologies is not present in many cases (9.1.1.1);
- alternative descriptions are not available for some videos (9.1.2.1).
- difficulty in perceiving and understanding information content and its correlations due to a lack of consistency in the formatting used (9.1.3.1);
- in some cases, colour is used as the only visual modality to represent information or distinguish a visual element (9.1.4.1);
- on all pages using the 200% zoom the content does not fit correctly and textual content is not identified due to lack of adequate contrast (9.1.4.3 9.1.4.4)
- no automatic resizing of enlarged content that avoids horizontal scrolling. (9.1.4.10);
- the documentation describing the accessibility and compatibility features of digital services and assistance is not always adequate (12.1.1 12.1.2 12.2.2 12.2.4);

Poste is planning a series of corrective actions to be implemented to improve accessibility.

The declaration was made using a third-party assessment in accordance with the requirements of Directive (EU) 2016/2102.
